Weekly Overview on Share Buyback Transactions

In accordance with applicable laws and regulations, and our press release of March 13, 2024, Greenyard announces in the overview below the number of treasury shares repurchased by financial intermediary Kepler Cheuvreux, through a discretionary mandate, during the specified period. The treasury shares are repurchased on the regulated market Euronext Brussels, in accordance with the authorization granted by the Extraordinary General Shareholders' Meeting on September 17, 2021. The share buyback program aims to fulfill obligations arising from long-term incentive plans.

As a result of the share buyback transactions conducted between October 4, 2024, and October 8, 2024 (inclusive), a total of 1 250 000 treasury shares have been repurchased from the start of the share buyback program on March 26, 2024, through to October 8, 2024. This volume corresponds to the total number of treasury shares for which the Board of Directors had granted a discretionary mandate to Kepler Cheuvreux. Consequently, the share buyback program is considered fully completed and ended as of October 8, 2024, following the close of the stock exchange.

As of today, the company holds a total of 2 326 406 treasury shares, representing 4,52% of the total number of issued shares (amounting to 51 515 443 shares in total (= denominator)).
